Our residential services(residential treatment, group home care, and treatment foster care) provide care for youth with significant behavior problems. Treatment is geared toward minimizing out-of-home stays and returning them to a less restrictive community placement as quickly as possible. These residential options provide a less expensive alternate to juvenile correctional facilities and inpatient psychiatric care.

4b (Code:) (Expenses \$ including grants of\$) (Revenue \$)
Our community support programs help adults with persistent mental illness remain in the community. A team consisting of psychiatrists, nurses, case managers, and mental health technicians provide an array of services to help meet the consumers' counseling and medical needs. This allows the individuals to stay in the community instead of being placed at state mental hospitals.

4c (Code:) (Expenses \$ including grants of\$) (Revenue \$)
Our community services (alternative education, day treatment, and family interaction services) provide support to families in their own homes and day programming for youth whose behavior problems prevent them from attending regular school. With these supports youth can remain in their homes and treatment can occur in that setting instead of more costly out-of-home options.

CEO evaluations are conducted annually by the board chair and vice-chair and reviewed by the Executive Committee of the board. The evaluation includes a written narrative completed by the CEO and an oral discussion with the board chair and vice-chair. The narrative and discussion includes a review of the agency's strategic objectives, professional goals, and any other evaluation criteria as established by the Executive Committee. A summary narrative of the evaluation is prepared by the board chair and/or vice-chair and submitted to the Executive Committee along with any salary/compensation recommendation. Any salary increase must be approved by the Executive Committee based on overall agency and individual performance as established through the annual review and goal setting process. The Executive Committee, at their discretion determines where on the CEO salary scale the current CEO should be. The final evaluation summary is then signed by the Board Chair and CEO and placed in the CEO's permanent file.
